_____ This Membership Agreement will be in force until cancelled in writing. Payment of membership dues are completed with on-going automatic renewal for subsequent months, unless cancelled by the athlete, the athlete’s parent/guardian, or BOOST Sports Performance. The membership dues price is locked in for the price you originally signed up for and will indefinitely charge until cancelled in writing.

_____ Payment of membership dues by cash or check will require the cumulative amount of the membership dues for the term of the plan to be paid in-full prior to services rendered to the athlete.

_____ The athlete/parent/guardian agrees to pay BOOST Sports Performance in monthly recurring dues at the rate of the selected membership with authorized automatic payment methods – credit/debit card or ACH. If for any reason, a payment fails to authorize, BOOST Sports Performance will notify the athlete/parent/guardian immediately and **a \$25 late fee will be applied to the balance if a valid form of payment is not provided within three (3) business days.**

_____ The full membership due as above is payable whether or not the athlete makes full use of the services. The membership fee or any part thereof is non-refundable and non-transferable.

_____ The athlete may use the services as regularly as he/she wishes as their membership permits during training sessions. BOOST Sports Performance reserves the right to change training times at their discretion.

_____ Memberships must be cancelled in writing by the athlete, the athlete’s parent/guardian, or BOOST Sports Performance within fifteen (15) days before the next billing date for the cancellation to take effect for the next month.

_____ The athlete/parent/guardian releases BOOST and all associates, employees, volunteers, officials, and agents associated with this program and facilities from any claims, liabilities, loss of service, and cause of action of any kind for personal injury including any property damage arising in any way out of participation.

_____ The athlete/parent/guardian authorizes the supervisors of BOOST to act for me according to their best judgment in an emergency requiring medical attention and the athlete is fully covered by personal family health plan in the event of sickness or injury.

_____ The athlete/parent/guardian has informed BOOST of any and all special health needs.

_____ The athlete/parent/guardian understands BOOST reserves the right to utilize images and/or photographs of all program participants for future use at BOOST discretion.

_____ The athlete will observe the rules and instructions of BOOST management and trainers. In the even that an athlete repeatedly disregards rules or continually interferes with the overall training and experience of other athletes and patients, BOOST Sports Performance may terminate, without refund, the membership of that athlete.
